Taking Steps to Save Energy

Like everyone else in rural Alaska, Choggiung is experiencing the impact of high energy costs. At times fuel prices accounted for as much as 30% of department budgets.

To offset the high cost of energy, several steps were implemented to lower energy costs for buildings operated by Choggiung.

The Court House, hotel, Kangiiqutak and mall's HVAC systems have been modified to increase efficiency and light fixtures were changed to energy saving fluorescents with motion sensors installed in low use areas. Fuel efficient boilers will be installed at the apartments to lower fuel and power consumption. Other measures are also being taken to upgrade and weatherize Choggiung properties: aging windows have been replaced at the 8 plex, the

Kangiiquataq building received a new roof and next year the Bristol Inn Mall will be sided.

But the largest effort to slash energy costs would be the decision to harness the renewable resource of wind.

At the City of Dillingham's 50th Anniversary of Statehood celebration, Choggiung was awarded a \$20,000 grant by the USDA Rural Development Program toward the purchase of the wind turbine.

This is the largest grant award to date for a renewable energy project in the State of Alaska.

Using figures on the current energy costs, the project will have a 3.5 to 5 year return. If all goes as planned, you will see the 48 foot wind turbine at the Court House by summer 2010.

- Choggiung will be applying for a grant with NRCS for a habitat improvement project. The project entails cutting brush on Choggiung land along the Nushagak River to pro-

NOTICE TO SHAREHOLDERS

In compliance with Alaska State law, the Board of Directors of Choggiung Limited is soliciting shareholders who wish to run for a seat on the Choggiung Limited Board of Directors. On the back of this letter you will find a DECLARATION OF CANDIDACY- form. If you are interested in running for a seat on the board, you ***MUST*** fill out the Declaration of Candidacy form and return it to the Choggiung Limited Office *by 5:00 p.m., Wednesday, November 18, 2009*. You should be aware that being a member of the Board of Directors is a serious commitment of time. If you fill out a Declaration of Candidacy and you are elected you must make that commitment. Contact the Choggiung Office if you have any questions about the number of meetings and the time required.

When the Board solicits proxies for Board elections, state law requires the proxies to name the candidates. To satisfy this requirement, we are now soliciting shareholders who want to run for a seat on the Board of Directors. State law also requires the corporation to give the shareholders certain information about the candidates who are named on the board solicited proxy form. To satisfy this requirement, we will ask each shareholder who submits a "Declaration of Candidacy" form to fill out an informational questionnaire. Candidates who provide the required information by Friday, December 4, 2009 will be named on the board solicited proxy form and will be eligible for the votes cast by the shareholders who sign the proxies.

*Candidates who do not declare their candidacy early and Candidates who do not provide the required information will ***NOT*** be eligible for board solicited proxy votes.*

All shareholders will continue to have the option of attending the annual meeting and voting in person. A shareholder will also be able to vote for the candidate(s) of his or her choice. Individuals who want to solicit proxies from other shareholders may continue to do so by using "non-board solicited proxies".

By soliciting shareholders interested in running for the board and having every candidate listed on the proxy form, you the shareholder have the right to vote for the candidate of your choice.
