Employment Opportunity - Spring 2013 Moose Habitat Enhancement




Last spring almost 87 acres of land was enhanced for the attraction of moose to the Nushagak River area. For the third year the USDA Natural Resources Conservation Service has partnered with Choggiung to improve designated areas on the Nushagak River for moose habitat.

Every spring a small group of workers travel to the Portage Creek area by snow machine to notch willow trees which induces new growth which the moose seem to prefer. 150 acres will be enhanced this coming spring.

Choggiung will recruit 3-5 laborers in late March to work on the next phase of the project. If you're in-

Board passes Resolution to Amend Restated By-Laws of the Corporation

At the August meeting the Board of Directors voted to amend the restated by-laws of the corporation by resolution. The amendment to Article I Section 2 reads: The annual meeting of the Stockholders shall be held in the month of March, on a date determined by the Board of Directors, or on such other date as the Board of Directors may determine from time to time, at the time designated by the Board of Directors, for the purpose of electing Directors, to consider reports of the affairs of the corporation, and for the transaction of such other business as may properly come before the meeting. Previously the annual meeting was held in February which consistently caused a time crunch in meeting deadlines to getting annual reports and proxy statements to shareholders. The Board voted unanimously to pass this section of the amended By-Laws.

Also amended was Article II Section 3: A regular meeting of the new Board of Directors shall be held without notice other than this By-law immediately following and at the same location as the annual meeting of Stockholders, at which newly elected Directors shall be seated and officers are elected by the Board of Directors. Regular meetings of the Board of Directors shall be held during the first week of every other month, in Dillingham, or at such other location determined by the Board of Directors. The Board of Directors may determine, by resolution or motion, the time and location for the holding of additional regular meetings without other notice than such resolution or motion, or provide for the holding of additional regular meetings, with notice provided in accordance with these By-Laws. The motion to amend this portion of the By-laws passed with a vote of 7-1.

Dividend checks equal to \$1.00 per share will be mailed out on Friday, December 14, 2012. The deadline for address changes for the upcoming distribution is Friday, November 30, 2012. If you need to update your address, please do so right away.

In order to deliver dividends, annual reports, proxy statements and other important information, we need to have a current address on file. Choggiung accepts address changes in writing only. Change of address, name change, gift of stock and stock will forms are available for download at www.choggiung.com/shareholders/forms. If you would like us to mail you a form you can contact us at (907) 842-5218. These forms are also available at the Choggiung office at 104 Main street in Dillingham or the BBNC office at 111 West 16th Avenue Suite 400 in Anchorage; forms may be completed and notarized at either of these locations.

NOTICE TO SHAREHOLDERS

In compliance with Alaska State law, the Board of Directors of Choggiung Ltd. is soliciting shareholders who wish to run for a seat on the Choggiung Ltd. Board of Directors. On the back of this letter you will find a <u>DECLARATION OF CANDIDACY</u> form. If you are interested in running for a seat on the board, you <u>MUST</u> fill out the Declaration of Candidacy form and return it to the Choggiung Ltd. office <u>by 5:00 p.m., Monday, November 26, 2012</u>. You should be aware that being a member of the Board of Directors is a serious commitment of time. If you fill out a Declaration of Candidacy and you are elected you must make that commitment. Contact the Choggiung office if you have any questions about the number of meetings and the time required.

When the Board solicits proxies for Board elections, state law requires the proxies to name the candidates. To satisfy this requirement, we are now soliciting shareholders who want to run for a seat on the Board of Directors. State law also requires the corporation to give the shareholders certain information about the candidates who are named on the board solicited proxy form. To satisfy this requirement, we will ask each shareholder who submits a "Declaration of Candidacy" form to fill out an informational questionnaire. Candidates who provide the required information by Wednesday, December 5, 2012 will be named on the board solicited proxy form and will be eligible for the votes cast by the shareholders who sign the proxies.

Candidates who do not declare their candidacy early and Candidates who do not provide the required information will NOT be eligible for board solicited proxy votes.

All shareholders will continue to have the option of attending the annual meeting and voting in person. A shareholder will also be able to vote for the candidate(s) of his or her choice. Individuals who want to solicit proxies from other shareholders may continue to do so by using "non-board solicited proxies".

By soliciting shareholders interested in running for the board and having every candidate listed on the proxy form, you the shareholder have the right to vote for the candidate of your choice.
